Modern Slavery Statement

Our Homes Approach:

1. Policy Commitment:

SPC Care Homes has a zero-tolerance policy towards modern slavery and human trafficking. We are committed to acting ethically and with integrity in all our business dealings and to implementing and enforcing effective systems and controls to prevent slavery and human trafficking in our operations and supply chains.

2. Organisational Structure:

SPC Care Homes operates as a provider of care services for the elderly and vulnerable individuals. While our operations primarily focus on the delivery of care services, we recognise the potential risks of modern slavery within our supply chains and are committed to addressing these risks.

3. Due Diligence Processes:

We conduct thorough due diligence assessments of our suppliers and subcontractors to identify and mitigate the risk of modern slavery and human trafficking. This includes assessing supplier policies, practices, and compliance with relevant laws and regulations.

4. Risk Assessment:

SPC Care Homes regularly evaluates the risk of modern slavery within our operations and supply chains, taking into account factors such as geographical location, nature of products and services, and supplier relationships. We are committed to taking proactive measures to address any identified risks.

5. Training and Awareness:

SPC Care Homes regularly reviews and updates our policies, procedures, and practices related to modern slavery and human trafficking to ensure their effectiveness and alignment with evolving standards and regulations.
